Programme model and funding

- Funded by the European Commission DG INTPA, implemented by International IDEA.
- Peer-to-peer model leveraging expertise from EU Member State Parliaments (EUMSPs); 23 engaged to date.
- Demand-driven based on priorities of partner parliaments
- Since 2019 has supported 24 partner parliaments in emerging democracies.
- Budget: €10.5 million over two phases (2019-2023, 2023-2026).



Key Objectives and Activities

- Strengthening parliamentary functions: representation, law-making, oversight, and budgeting.
- Enhancing parliaments' capacities on global challenges, focusing on youth and women's participation.
- Providing peer-to-peer exchanges, technical assistance, training, and parliamentary tool development.
- Supporting parliamentary research, digital transformation, and crisis governance.



Some Headline Results and Impact

- 1,934 participants from partner parliaments engaged in activities.
- 400+ MPs and staff from EU parliaments participated in peer-to-peer exchanges.
- 125 knowledge products, handbooks, and guidelines produced.
- 96% of participants reported satisfaction with partnerships.
- 82% applied knowledge on cross-cutting issues (gender, youth, climate change).
- 5,200 participants engaged in global events and summer schools.

Phase II Results Q1 2023 - Q3 2024



Outcome - Partnerships:

Improved Effectiveness, Accountability and Transparency in Partner Parliaments



- **52** partnership activities successfully finalised, including experience exchanges, in-person and online training, workshops, working group meetings and attachments
- 5 knowledge products resulting from partnership activities
- 10 partner parliaments in Phase II



- **5** scoping missions to **Benin, Nepal, Ukraine, Uruguay** and **Zambia**
- 3 baseline assessments conducted with **Botswana**, **Nepal** and **Zambia**


96% of post-activity survey respondents state that they will be able to apply what they learned in their day-to-day work



253 Engagements: EUMSPs & EU Parliament **driving action** across all outcomes



(counts work planning meetings and ongoing and completed activities)



- 198 expert EUMSPs engaged in partnership activities
- 144 person-days EUMSPs offered
- 97% of post-activity survey respondents are satisfied wit the training/activity they participated in

Why Parliamentary Strengthening

Montesquieu on why parliaments are essential to democracy

"In every government there are three sorts of power: the legislative; the executive in respect to things dependent on the law of nations; and the judiciary in regard to matters that depend on the civil law....

When the legislative and executive powers are united in the same person, or in the same body of magistrates, there can be no liberty; because apprehensions may arise, lest the same monarch or senate should enact tyrannical laws, to execute them in a tyrannical manner...

There would be an end of every thing, were the same man, or the same body, whether of the nobles or of the people, to exercise those three powers, that of enacting laws, that of executing the public resolutions, and of trying the causes of individuals."

Parliaments and Economic Outcomes

- Parliamentary regimes are associated with faster economic growth and greater stability compared to presidential systems.
- Well-functioning parliaments contribute to economic policy stability.
- Parliamentary systems foster stronger, more inclusive institutions, contributing to economic stability.
- Democracies with strong parliamentary institutions tend to create policies that promote long-term growth.
- Parliamentary institutions provide mechanisms for better economic oversight and accountability.










Parliamentary Development tiny proportion of International Development Spending












Support to Parliaments and Parties as Overall Share of DAC Governance Funding













Focus on Partnerships with Accession Parliaments

Montenegro and Ukraine

Montenegro Key Details

- Partnership: Feb 2021 Jul 2023
- Aimed to enhance oversight & legal harmonization
- 14 activities (virtual & in-person)
- 8 EU national parliaments contributed expertise
- EUMSPs MPs and staff contributed their expertise and time without charge
- Inter Pares covered all out of pocket expenses (travel, interpretation, etc.)

Results & Impact

- 146 participants trained, including 28 MPs
- 97% of staff reported knowledge improvement
- 55% applied new knowledge in daily work
- 93% satisfaction from MNE & EU participants
- 3 recommendation reports prepared







Lessons Learned

- Peer-to-peer exchange was highly effective
- Relevance for Montenegro as an EU candidate country
- Political stability is crucial for success
- Flexibility & adaptive implementation needed











UkraineKey Details

- Partnership in Ukraine was launched in April 2023 to enhance the Verkhovna Rada's (VRU) capacity to perform its constitutional roles during wartime and to support the EU accession process.
- 19 EU Member State Parliaments (EUMSPs) and the European Parliament are actively engaged in supporting the initiative.
- The project focuses on seven key areas, with an initial emphasis on EU integration and budgetary processes.

Strengthen VRU in budget process

- March 2024 peer-to-peer workshop in Prague provided insights into parliamentary budgetary processes across Europe, 12 EUMSPs and SAOs exchanged with VRU MPs and staff.
- A study visit to Berlin offered firsthand exposure to Bundestag budget practices.
- May 2024 workshop in Brussels, in collaboration with the European Parliament, trained 10 VRU and Audit Chamber staff in fiscal policy oversight.
- January 2025 mission of Budget Cimmittee MPs and staff to Austrian Parliament to address specific PBO implementation questions
- INTER PARES continues to mobilize EUMSP support to help establish a Parliamentary Budget Office.











Ukraine EU Accession Support

- A two-day workshop (June 2024) engaged 200 VRU representatives on Ukraine's EU accession negotiations.
- 12 EU national parliaments (15 chambers) shared their direct experiences with EU accession.
- March 2025 workshop co-organized with European Parliament for Ukrainian MPs on effective communication of EU accession process and opportunities.
- Q2/Q3 2025 workshop and study tour will provide comparative examples of parliamentary committees' roles in EU integration.











Oversight, Foresight, Research Capacity

- February 2024, INTER PARES supported the German Bundestag in organizing a peer-to-peer study visit for VRU parliamentary administrators.
- Topics included parliamentary oversight, committee work, and civic engagement.
- November 2024 workshop in Kyiv on parliamentary foresight, involving Lithuanian Seimas (in person), Danish Folketing, French National assembly, European Parlisment
- Internship of VRU foresight research staff at Lithuanian Seimas, Q2 2025











Some Challenges

Montenegro

- Political instability affected implementation
- Changes in government & parliamentary boycotts
- Staff focus exchanges and institutional development effective but several activities wth MPs had to be cancelled due to boycotts etc.

Ukraine

- War travel inward and outward difficult, impact on reform focus, state decision-making more centralised, etc.
- EU accession process under development, specific VRU role not yet clear
- Change in US foreign aid policy and programmes likely to affect internationl support to parliamentary strengthening

Ireland House of the Oireachtas

- Successful Inter Pares partnership with the National Assembly of the Gambia, which resulted in the financial autonomy of the Assembly – the Houses of the Oireachtas also supported the National Assembly of the Gambia in introducing a Code of Conduct for Members which the NA had never considered before
- The Irish PBO is also always happy to share their expertise either on an ad-hoc basis, or as part of peer-to-peer engagement such as in Nepal and Ukraine

Lithuanian Seimas

- Very engaged with Uzbekistan and Ukraine (foresight, research, EU integration)
- Managed to open up groundbreaking cooperation with Uzbekistan











Honourable mentions: Croatia and Cyprus

Croatia

 Worked intensively with Montenegro and hosted a fellowship for a parliamentary staffer from the Parliament of Montenegro on EU acquis compliance; fellowships were hosted also by the Italian Chamber of Deputies, French National Assembly and Senate, and the Czech Parliament

Cyprus

 Has become gradually more engaged through the partnerships with Uzbekistan and Botswana and we really appreciate it, given that it is a small parliament with limited resources
